#### **Guidance:**

Apply the BACCM to think holistically about business situations. Use it to understand how needs arise, how change is pursued, and how value is defined and delivered in context through stakeholder collaboration and solution design.

# 1.3 Explain how business analysis supports value creation and benefits organizations in various industries.

### **Key Takeaways:**

#### **General Awareness:**

Understand that business analysis helps organizations make better decisions, solve problems, and deliver meaningful results.

#### **Practical Knowledge:**

Show how business analysis identifies opportunities, reduces risk, and improves outcomes—regardless of industry or domain.
